The Law Library has also taken a lead role in forming and promoting the Global Legal Information Network (GLIN). GLIN is a unique public resource for laws, regulations, judicial decisions and other



legal materials from around the world. GL11 Reaches Out to Next Generation LIS Professionals

As the Eleventh International Conference on Grey Literature approaches, the organizers are reaching out to next generation library and information professionals. Ten students from two master's program in the United States will be attending the conference. Their attendance is funded by GreyNet as well as by their home institutions. Six graduate students from Catholic University of America (Washington, DC) along with Prof. Ingrid Hsieh-Yee and four graduate students from Pratt Institute (New York, NY) along with Prof. Debbie Rabina will actively participate in GL11. Learning to understand and identify underlying issues and implementing solutions and best practices for managing grey literature in a variety of information environments are among their goals. Students will also be working with their professors on projects and terms papers related to the conference themes. Panel to Explore OpenSIGLE's Capacity for Grey Literature

The GL11 Panel on OpenSIGLE is based on a paper presented at the Tenth International Conference on Grey Literature (GL10) in which GreyNet's collections of conference preprints were made accessible via the OpenSIGLE Repository. OpenSIGLE offers a unique distribution channel for European grey literature with roots dating back a quarter century. In the first part of the panel session, the experience of INIST as service provider and GreyNet as data provider will be discussed including recent developments. Later in the session, the draft of a project proposal will be elaborated. The proposal seeks to explore the capacity required for the OpenSIGLE Repository to develop in multilateral and international cooperation in support of European research infrastructures committed to the open access of grey literature collections and resources. Emphasis is placed on the involvement of libraries, research centers, and institutions of higher education, as well as, requirements for a grey literature network service to sustain further development, exploitation, and promotion of the OpenSIGLE Repository. <http://opensigle.inist.fr/pages/about.jsp>

Joachim Schöpfel

Former head of the department of e-publishing and document supply at INIST (CNRS), Dr. Joachim Schöpfel was elected this summer director of the department of information and documentation sciences of the Charles de Gaulle University in Lille, France. His objectives for the next years are new BA and Master programs for LIS students, the development of partnerships with information industry and services, and international networking. Joachim Schöpfel is lecturing on scientific information, digital libraries, author's rights and professional communication. His ongoing research projects at the Lille GERIICO laboratory are on assessment of the usage of digital resources and on the development of open access to scientific information. He also works with the CNRS institute of communication sciences on new metrics for the evaluation and assessment of scientific production. Future projects are on functional concepts of scientific communication, e-science and industrial applications of information and communication nanotechnologies. He remains deeply involved with the grey community, especially with the OpenSIGLE project and with research on GL in open archives.

Maximilian Stempfhuber

Former Deputy Director of GESIS (Leibniz-Institute for the Social Sciences), Dr. Maximilian Stempfhuber was appointed this summer Head of ICT at RWTH Aachen University, Germany. He holds a degree in information science and business computing (M. A.) from the University of Regensburg and a PhD in computer science from the University of Koblenz-Landau. He works as Head of ICT at RWTH Aachen University, University Library. From 1995 until July 2009 he worked at GESIS – Leibniz-Institute for the Social Sciences (formerly IZ Social Science Information Centre) in Bonn, first as a researcher in the project ELVIRA, funded by the German Federal Ministry of Economics and Technology (BMWi) where he developed an integrated information system for market research. Since 2000 he was Head of Research and Development and since 2004 Deputy Directors of GESIS-IZ. Since 2002 he is lecturing in human-computer interaction and computational visualistics at the University of Koblenz-Landau. He is board member of several national and international organizations aiming at improving the exchange of research information, supporting scholarly publishing and promoting Open Access. His research interests are in human-computer interaction, computational visualistics, information retrieval, and digital libraries.
